

CARDSCAN PACKAGE (Ink to Digital Fingerprints)

PROCEDURE EXPLANATIONS:

This is an explanation of the process, processing time, fees, remit to address and contact information for the completion and submission of your Cardscan package.

NOTE: Our Company has been certified to submit paper (ink and roll) fingerprints by scanning them and forwarding them electronically to the RCMP.

TIME

•The RCMP advises that, if no criminal record exists, the process takes on average 72 hours from the time the fingerprints are electronically submitted. This average does not include time required for processing by mail.

FEES

- •The cost will be a total of \$128.50 CDN. The total cost consists of \$90.00 Scanning fee (+taxes) +\$25.00 RCMP processing fee.
- •Exception for Canadian permanent residence and Canadian Citizenship applications. Fees for these types of applications will be \$103.50 (\$90.00 to taxes). Please include your Client ID # associated with your Canadian
- + taxes). Please include your Client ID # associated with your Canadian immigration file and a copy of the Canadian citizenship letter requesting the fingerprints.
- •Fees will only be charged after fingerprints have been scanned for suitability and are ready to be electronically submitted to the RCMP.

PAYMENT

- •Payment can be made by credit card. Upon receipt of your fingerprints you will receive an invoice to your email address requesting an on-line payment.
- •Or you may send a Canadian money order in CAD funds with your application. Please make money orders payable to C5 ID and Fingerprinting Solutions.

RESULTS

- •The RCMP will mail fingerprint results back to you by regular mail.
- •If you have completed the *Third Party Consent Form* (DOC#2) the results will be mailed out by the RCMP to the address noted on DOC#2 by regular mail,

FILLING OUT THE FORMS:

☐ Complete Document #1 RCMP C216 FINGERPRINT FORM – see attached PDF

This is the RCMP fingerprint form. It can be printed off on either $8.5" \times 11"$ or $8.5" \times 14"$ paper. However, it is not mandatory that the RCMP fingerprint form be utilized. Many police services and agencies have their own fingerprinting forms and any such form can and may be used provided it allows for the capture of 10 rolled and 10 flat fingerprint impressions, the full name of the applicant, Date of Birth, and stamp or name and address of the department or agency that rolled the fingerprints. Note: It is important that you send the "original" fingerprints and not photocopies.

Document #1- Complete the following (print clearly)

- Your signature & the signature of the official taking the fingerprints.
- The date
- Full legal name
- Date of birth
- Sex
- Your telephone number
- Your home address
- Reason for the application (example: visa/immigration/pardon etc.)
- The stamp or name and address of the department or agency that provided the fingerprints.

Note: We require 10 rolled and 10 flat fingerprint impressions.

"Level of clearance" field is **NOT** required.

This Document is used in order to give the RCMP your permission to mail the Canadian Criminal Record Check results to a third party.

If this form is not included with your application the RCMP will send the results of the Criminal Record Check to your address (as noted on the fingerprint form) by regular mail.

When the RCMP results are to be delivered outside of Canada we suggest that our clients complete the **Third Party Consent Form** in order to have them mailed to our address in Charlottetown. When we receive the results we will send you an email with a scanned copy provided an email address is included in your application. Courier services with tracking are available for the printed results of the Canadian Criminal Record Check for a nominal fee.

- One fingerprint impression (mark which finger used; in the space provided.)

Note: We require only one copy of the consent form.

SCANNING AND PAYMENT

When fingerprints are received they are electronically scanned to ensure the quality is sufficient for submission to the RCMP.

We will advise you via telephone or email about the suitability of the fingerprints provided. If the **prints** are not suitable for scanning we will request you to have additional prints taken and forwarded to us

When fingerprints are determined to be of good quality and are deemed suitable for electronic submission to the RCMP, payment will be requested via an email invoice for an on-line payment via credit card or Money orders as submitted will be deposited to our account. Once we process full payment C5 ID will send the fingerprints to the RCMP electronically

The RCMP's processing time is on average 3 business days **plus** the time required for ground mail processing.

NOTE IF THERE IS A CRIMINAL RECORD ASSOCIATED WITH THE FINGERPRINTS THE RCMP'S PROCESSING TIME MAY INCREASE SIGNIFICANTLY.



THE RESULTS

If you completed DOCUMENT #2 (THIRD PARTY CONSENT FORM) with C5 ID and Fingerprinting Solutions address, the results will be sent to our office.

Upon arrival we will contact you by emailing you a scanned copy of the results. If you have chosen to have results couriered to your attention or to a named third party, C5 ID will include those fees in our invoice. We will only charge the actual courier charges plus \$10.00 surcharge for processing. We will not courier any results until payment for these services has been processed. This service is **ONLY** available for clients who complete the third party consent form indicating C5 ID is to receive their results from the RCMP.

If you completed DOCUMENT #2 (THIRD PARTY CONSENT FORM) with a third party address other than C5 ID. RCMP will mail out the results by regular mail to that address.

If you did not complete the consent form the results will be mailed out to your address on the applicant information form by regular mail.
